IV. CONTENT AND PROPERTY RIGHT PROTECTIONS

You agree that all content located at titleX is the sole property of titleX. You understand and agree that the information in, or derived from titleX, including communications, photos, video, graphics and other material may not be copied, republished, redistributed, transmitted, altered, edited or exploited in any manner for any purpose, without notice to titleX and the prior express written permission of titleX. titleX neither warrants nor represents that your use of materials displayed on the Site will not infringe rights of third parties not owned by or affiliated with titleX;

USE OF POSSESSION OF IDENTIFYING INFORMATION: You also agree that if the content located at titleX contains identifying information of another person you will not obtain, possess, transfer, or use such identifying information without the other person's consent and with intent to harm or defraud that person, in violation of § 32.51(b) of the Texas Penal Code.

INDEMNITY: You further agree that in the event of litigation against titleX arising out of your use of the content located at titleX, including the illegal use of a person's identifying information, as stated above, you will indemnify titleX and hold it harmless from any and all claims and causes of action of any kind, including claims for actual damages, penalties, exemplary damages, and attorney fees, and including titleX's attorney fees, arising out or in defense of such litigation.

Therefore, the parties agree that the foregoing amendment shall be hereinafter considered a part of the contract referred to above and incorporated by reference therein for all purposes. The amendment shall be subject to any and all other provisions of the contract, with the exception of the parts or provisions of the contract, which have been modified by this amendment.
